in the Purchase of a CD Rescue Vehicle if . . .

1. A local rescue organization is in existence or in the planning stage at the time the project application is submitted.
2. An acceptable rescue training program is either in the planning stage or has been established.
3. The vehicle will be made available for use in stricken areas under established mutual aid or mobile support plans or interstate compact or in lieu thereof, an agreement will be reached with the appropriate Regional Office for use of such vehicles across state lines when requested by the Regional Office during an emergency.
4. Suitable arrangements will be made for the location and housing of the vehicle to provide reasonable assurance of its effective use after an enemy attack.
5. An effective dispersal plan has been or will be established if the vehicle is to be housed in or adjacent to a metropolitan area.
